Engagement of Retired/Ex NTPC personnel for Chemical wing related works of thermal plants of MPPGCL

1. Objective of Tender

- 1.1. MPPGCL has four thermal plants under its aegis at Birsinghpur, Chachai, Dongaliya and Sarni. Units installed range in capacity from 210 MW to 660 MW super critical units.
- 1.2. MPPGCL intends to engage 07 numbers of experienced professionals having adequate work experience in Power plant chemistry works.
- 1.3. Accordingly, for improvement in chemical related works professionals shall be engaged and deputed to HQ Jabalpur & all TPS of MPPGCL for works related to thermal plant chemistry, works related to coal sampling & compliance of environment norms etc.
- 1.4. The request for submission of tender in no manner is a compulsion for engaging the persons. The interested persons in no manner shall become eligible, merely by submitting their offer for the same.

2. Brief Detail of MPPGCL

- 2.1. MP Power Generating Company Ltd, Jabalpur (MPPGCL) is the State-owned power generating company of Madhya Pradesh with its Head quarter located at Jabalpur having its running Thermal & Hydel Power Stations located at various locations in the state of Madhya Pradesh. The brief summary of existing thermal units in operation as on 30th April 2022 are as under:-

3. Scope of work :

Scope of work shall be to provide expert services to MPPGCL for “Technical support in chemical wing related issues” of all thermal power station of MPPGCL, as under:

- To assist/support MPPGCL for maintaining effective operation of units.

- To provide technical advice to MPPGCL during operation of all units/various systems which shall also be reviewed / discussed during meeting for their implementation & to develop an effective system.
- Monitoring of SWAS system / grab sample readings / water-steam quality and report any deviation along with remedial suggestions.
- Daily monitoring of coal sampling being carried out and to suggest any improvement in procedure.
- The engaged personals have to be acquainted with applicable environment norms for thermal power plants and shall monitor their compliances.
- To assist for monitoring of running parameters of units, regularly to improve unit efficiency.
- To provide technical advice on reasons for deviation of operation parameters and ways to improve them.
- To provide technical advice on unit trippings during analysis and suggest suitable remedial actions if required.
- To provide technical advice on analysis of chemical parameters, root cause analysis of deviation with standard parameter and providing suitable recommendations.
- To analyze the O&M practices adopted in relation to chemical wing in thermal power stations and giving suggestions for improvement if any.
- The experts posted at HQ shall provide expert advice on various technical matters as and when required in all the Thermal power stations of MPPGCL. This shall include visits to all the power stations on requirement.
- Any other Expert advice required for O&M of plants.

4. Period of Contract

- The period of Contract shall be initially for 12 months starting from the date mentioned in the offer letter.
- The above period shall be extendable, on mutual consent with escalation of 5% per year on monthly remuneration.

5. Termination / short closure of contract

- 5.1 In the event when both the parties mutually agree to terminate the contract on account of force majeure or any other reason, the termination shall take effect from the date and time to be mutually agreed.
- 5.2 MPPGCL shall also reserve the right for short closure of the contract by giving one month's notice for any engaged personnel.
- 5.3 In the event of termination of contract, the charges shall be paid to you for all services performed up to the date of termination or as per actual.

6. Earnest Money Deposit to be Provided by Bidders

7. Pre-Qualifying Criteria & Minimum Necessary Documents to be submitted for consideration of engagement

Retired NTPC personnel / Ex-NTPC personnel fulfilling below mentioned criteria shall be eligible to apply for consideration of the subject work. Adequate documentary proof needs to be submitted in support of the same.

4.1. Minimum Educational Qualification :

M.Sc (Chemistry) / B.E. or B.Tech in Chemical Engineering.

4.2. Work Experience :

Minimum 15 years work experience in Chemical Wing in thermal power plants of NTPC with minimum capacity unit of 210 MW.

Desirable : Due preference shall be given to personnel having exposure to super-critical units.

4.3. Age Limit : Maximum age at the time of opening of the offers shall not be more than 65 years.

The offers of the personnel meeting above criteria and submitting the required documents in support thereof shall only be opened.

8. Submission of Offer by the Bidder

b. The above officer may be contacted for seeking additional information, if any. He shall be liable to provide the information to the extent found necessary for submission of offer within legal framework and are not confidential in nature. **The last date of submission of offer is 25-June-2022.**

c. The offer must be submitted in a sealed envelope having superscription as **"For engagement of Retired/Ex NTPC personnel for chemical wing related works of thermal plants of MPPGCL"**. On this envelope, please also superscribe the name and address of the personnel. Envelope should also contain Qualification & Experience related documents

Please note that if proper superscription is not made on the envelope and they are not properly sealed, MPPGCL shall not be responsible for pre-mature opening of the bids.

9. Late receipt of Tender Offer

The offers received up to the due date shall only be scrutinized by MPPGCL. Any bid/proposal received by MPPGCL after the deadline for submission of offers prescribed will not be considered. MPPGCL will not be responsible for late receipt of offers because of postal delay or other reasons whatsoever.

10. Opening of Offers :-

The personnel, who qualify the PQR conditions and have submitted requisite documents in their support, shall be considered as Qualified.

Suitable dates/venue shall be notified by MPPGCL. The personnel may be present to witness the opening processes, if interested. The offers shall be opened on notified dates/venue, even if no representative of any firm remains present.

The dates shall be notified on MPPGCL's website (www.mppgcl.mp.gov.in).

11. Validity of Offers

The offers should be valid for six months period from the date of opening.

12. MPPGCL's Right to accept or reject any or all offers

12.1 Notwithstanding anything mentioned in the tender document, MPPGCL reserves its right to amend, modify, cancel and or otherwise reject any offer without assigning any reasons thereof.

12.2 MPPGCL reserves the right to reject any/all offer(s) which is/are not submitted according to the instructions or without assigning the reason.

13. Selection Criteria

The bidders will have to agree to all the terms and conditions stipulated in this offer. Offers with deviations are liable for rejection.

If more offers are received than after due scrutiny of the documents all qualified personnel may be called for interview, if felt necessary. On the basis of qualification documents, and interview (if called for) the personnel shall be engaged on the discretion of MPPGCL.

14. Security Deposit to be Provided by Successful Bidder

15. Jurisdiction of Court

- All difference or disputes between the parties arising out of or in connection with these presents shall in the first instance be amicably settled / resolved between the parties.
- Failing amicable settlement amongst the parties the same shall be settled through arbitration in terms of the Indian Arbitration Act 1996. The venue of Arbitration shall be Jabalpur, Madhya Pradesh, India.
- Any dispute or difference, arising under, out of, or in connection with this document /contract, shall be subject to exclusive jurisdiction of competent court of Madhya Pradesh situated at Jabalpur.

16. General terms of condition

i) Working Hours :Your working hours will be official working hours of MPPGCL at head quarter/TPS.

ii) Leave Entitlement: During the assignment personnel shall be Entitled for one day paid leave for every 15 days of working. (Including intervening weekly holidays and gazette holidays) in addition to the holidays as applicable to MPPGCL.

17. Inputs Required from MPPGCL

Technical detail of plant, O&M manuals and Plant O&M history and performance data etc. shall be provided as and when desired, subjected to its availability.

18. Reimbursement of Tour & Travel Expenses

For official tours undertaken for the job related to the assignment, TA/DA and other boarding charges shall be payable as per entitlement applicable to SE level of MPPGCL.

19. Taxes & Duties

GST/duties levied by any act/notification of central/state government or any other authority arising out of this contract, shall be borne by MPPGCL or reimbursed at actual to you, in case you called upon to pay the same directly to the authority concerned.

20. Terms of payment

(i) 100% payment shall be made by MPPGCL as per actual deployment along with payment towards tour / travel for preceding month, based on monthly invoice raised.

(ii) The payment for tour & travel cost explained above will be released against invoice raised for the same with certification.

(iii) All payments will be made through bank transfer/Check/DD; MPPGCL shall endeavor to make all payments within 30 days from date of invoice.

The rate shall be pro-rated in case of deployment for a part of the month (which shall be applicable for unpaid leaves in the month) on the basis of actual no. of days in a month.

21.0 Remuneration & Facilities to be provided by MPPGCL

- The person selected shall be entitled for a fixed remuneration of Rupees 1.10 lakhs/month.
- MPPGCL shall provide suitable accommodation as available and vehicle free of cost.
- MPPGCL's medical facilities / club facilities shall be also be provided as available.
- Suitable office accommodation along with Desktop/Laptop shall also be provided by MPPGCL.

22.0 Force majeure

Force majeure is herein defined as any cause, beyond the reasonable control of MPPGCL or you as the case may be with which a reasonable amount of diligence could not have been foreseen & which substantially affects the performance of the respective obligations of the parties, such as:

- a) Act of god (such as but not limited to tidal waves, epidemics, flood, draught, cyclone, lightning, tsunami, earthquake etc.);
- b) Acts of Government (domestic or foreign) including but not limited to war, hostilities (whether war declared or not), invasion, act of foreign enemies, mobilization, requisition or embargos;
- c) Rebellion, revolution, insurrection, civil mutiny, commotion, riot terrorist or militants acts, accident by fire, explosion and / or any other cause beyond the control of parties;
- d) Acts of any Government, including but not limited to war, declared or undeclared, priorities, quarantines;
- e) Hostilities, revolutions, riots, civil commotions, illegal strikes including in the Premises of the contractors.

Provided that either party shall within 7 days from the occurrence of such a cause notify the other in writing of the same. You shall not be liable for delays in performing your obligations or delays in respect there-of due to any cause whatsoever beyond your control including force majeure cause as briefly referred to and/ or defined above.

23.0 Limitation of liability

- (i) **Indemnification:** MPPGCL shall indemnify & hold you harmless, against any claims, demands, cost, charges, taxes, duties, damages and expenses brought to it by performance of work under this assignment by you except those due to willful act. Under this assignment your obligations shall be limited as provided above.

(ii) Indirect Liability or consequential damages

Neither you nor MPPGCL shall be liable to the other in any manner what so ever by way of indemnity or by reason of any breach of the terms under this assignment or of statutory duty or by reasons of trot for any loss of profit, loss of use, loss of revenue, loss of production or for any other in direct or consequential damages that may be suffered by the other.

(iii) Ownership & risk of loss

MPPGCL shall retain legal title of ownership of the plant, equipment / station and shall remain the legal & beneficial owner of the plant & MPPGCL shall be responsible for any risk of loss with respect to the plant. However, any consequential losses or damage to the property /personnel of MPPGCL arising out of wrong advice or your willful act shall be on your account & your responsibility.
