**(2) e-Tendering :-**

- (i) For participation in e-tendering module of MPPGCL, it is mandatory for prospective bidders to get it registered on e-procurement website i.e. [www.mptenders.gov.in](http://www.mptenders.gov.in). Therefore, it is advised to all prospective bidders to get them registered by completing the requirements for online registration including payment of requisite fee at the earliest.
- (ii) The registration fees for the e-procurement website should be borne by the bidders and no exemptions are allowed in registration fees.
- (iii) Service and gateway charges as applicable shall be borne by the bidders.
- (iv) The bidders are required to sign their bids online using Class-III Digital Signature Certificates (DSC). Bidders are therefore advised to obtain the same at the earliest without waiting for the due date of bid submission.
- (v) The issuance of Digital Signature Certificate may take up to 7 to 10 working days. In such situations MPPGCL will not be responsible for delay in issue of Digital Signature Certificate.
- (vi) If bidder is going first time for e-tendering, then it is obligatory on the part of bidder to fulfill all formalities such as registration, obtaining Digital Signature Certificate etc. well in advance.
- (vii) Bidders are requested to visit e-procurement website regularly for any clarifications and/ or amendments and/or due date extension.
- (viii) Bidder must positively complete online e-tendering procedure at e-procurement website i.e. [mptenders.gov.in](http://mptenders.gov.in).

### **(3) Exemption for MSEs, START UP and SSI of MP from payment of Tender Fees**

The bidders registered in the state of Madhya Pradesh as Micro & Small Enterprises (MSEs) / START UP / S.S.I. units with D.I.C. (District Industries Center) / Khadi & Village Industries Commission (KVIC) / Khadi & Village Industries Board (KVIB) / Coir Board / Directorate of Handicrafts and Handloom / Udyog Aadhar Memorandum (UAM) or any other body specified by Ministry of Micro, Small & Medium Enterprises (MoMSME) for the tendered item(s) are exempted from paying the tender fees; however such firms shall have to upload the requisite documents on e-procurement website. **In case of submission of invalid documents towards exemption of Tender Fee, the bids shall be summarily rejected without any further correspondence in the matter. No shortfall window will be created towards submission of exemption document for Tender Fee. Part of Clause No. 1.15(II) of Standard Bid Documents in respect of creation of shortfall window shall not be applicable. As such, bidder is requested to submit only valid documents as per NIT.**

**NOTE:-** Apart from above, no other bidder is exempted from payment of Tender Fees.

### **(4) Earnest Money Deposit:**

1. The EMD of respective amount as indicated against the tender is to be submitted by bidder through net banking/RTGS/NEFT on website at the time of submission of e-tender.
2. No offer will be accepted without valid Earnest Money Deposit unless exempted as detailed in point No. (1.10) of "Instructions to Bidders (ITB) in Standard Bid Document".
3. Bidders who are fulfilling the criteria laid down in Clause No. 1.10 of Standard Bid Document (SBD) towards exemption of EMD, shall upload the valid documents towards exemption of EMD. **In case of submission of invalid documents towards exemption of EMD, the bids shall be summarily rejected without any further correspondence in the matter.**
4. For this, the bidder has to opt for "exemption" option on the website and to upload scanned copy of document for exemption of EMD. **No shortfall window will be created towards submission of exemption document for EMD. Part of Clause No. 1.15(VII) (C) of Standard Bid Document in respect of creation of shortfall window shall not be applicable.**
5. **Submission of EMD in the form of BG:-** In case of opting for BG, bidder is required to upload scanned copy of BG on e-Portal. Original BG in physical form should be submitted only after opening of Bid(s), within seven days thereafter. The bid of such bidders shall be considered for evaluation only after receipt of

original BG in physical form and its verification. In no case, physical contact should happen between bidder and MPPGCL officials before opening of T & C bids.

Further no correspondence with regard to EMD shall be done through shortfall window. The offers received without EMD shall be summarily rejected.

(5) **Credential and PQR:**

The prospective bidders, who have adequate documents to fulfill criteria of credential and Pre-Qualification-Requirement (PQR) as detailed hereunder for the tender, will upload scanned self-certified copies of requisite documents as required in e-tendering process. The credential documents and Pre-Qualification Requirement for the tender are as under:-

**A. Status of Bidder:** - The bidder should be contractor/ firm/ service provider/ Joint Venture (JV) Company. Bidding through Consortium is not permitted. GST & EPF registration is to be uploaded.

(i) Copy of PAN Card is to be uploaded.

(ii) Registration certificate from Registrar of Firm/Companies, in case of firm/ Company/ Joint Venture Company is to be uploaded.

**B. Past Experience :-**

1. Copies of successfully executed orders (including part executed) by the bidder as a main contractor for same or similar work {*Similar work means work of coal lifting and its transportation by road from mines of CIL subsidiaries and/or SCCL with experience in liaisoning with Railways/CIL subsidiaries/SCCL i.e., arranging rakes, dispatches coal from own or leased Private siding or Goods shed Rly. siding by loading of coal into railway wagons through own arrangement with monitoring the rake movement etc. up to the destination Power house. The order copies should indicate the above work.*} for 0.60 Lakh MT( 60,000 MT) quantity or more in state Owned Power Generating Companies / Other Captive Power Utilities of PSU / NTPC / Govt. Industries / Departments / Semi Govt. Industries / Departments / PSUs in India placed in last 7 years ending with initial date of opening of bid are to be uploaded. This order execution should be within the six(6) months. It may be through single or multiple orders (in parallel), but in case of multiple orders; these should be within a single span of time period of 6 months.
2. The work execution certificate by the customers alongwith self attested un-priced copies of aforesaid work order(s) should be submitted.

3. Those who have worked in MPPGCL earlier as lead partner of any consortium, may also quote as a single bidder using past experience of such consortium.
4. For Past performance certificates - If worked with MPEB/ MPSEB/ MPPGCL in Past for similar work, then it is mandatory to provide Satisfactory Performance Certificate for the same. Failing this, the offer shall not be considered.

## **C. Financial Qualification: -**

1. Average annual turnover of the bidder during 3 consecutive financial years (FYs) in last 4 FYs should not be less than the Rupees 0.53 Crore.
2. The net worth for the last financial year should be positive.
3. To substantiate the above requirement, documents such as certificate from chartered accountant containing Unique Document Identification Number (UDIN) and Audited Balance Sheet & Profit & Loss Account should be submitted. Other income indicated in Profit & Loss Account of bidder shall not be considered for the purpose of turnover calculation.
4. Participating bidder (except PSUs / Government Organizations) is required to upload notarized affidavit on non-judicial stamp paper of appropriate value (which is presently Rs. 100/-) that "Neither the bidder nor any of its sister concern are facing Insolvency & Bankruptcy".

## **D. Special Requirement:-**

1. Bidder should have ownership of required vehicles(tippers) for 167 MT carrying capacity. Valid Registration certificate of owned vehicle alongwith a list of owned vehicle indicating the validity of registration and capacity should also be submitted.
2. Bidder should have at least one loader registered in his name with min. capacity of 2.25 Cu.M or should have legal agreement for hiring of such or higher capacity loader. The bidder is required to give an undertaking in the form of an affidavit (on non-judicial stamp value Rs-100/-) to deploy equipment/ tippers/ Pay loaders commensurate with the tendered quantity.
3. Arrangement of Railway Siding for coal transportation:- Bidder should have valid permission/consent for stacking, loading & dispatch of coal from Pandhar-Pavani(

E. In addition to the above, the following documents must also be uploaded along with the PQR documents of the bidder, failing which the offer shall be liable for rejection.

1. The undertaking as per Annexure-IV of SBD (clause no. 1.52 i.e. Corrupt practice/ Fraudulent Practice of Instructions to Bidders) is to be uploaded/ submitted with techno-commercial offer for observing fair and ethical practices by all the bidders except Government Organizations and/or Public Sector Undertakings.
3. The affidavit for No Banning/ Black Listing/ Delisting on non-judicial stamp paper of Rs.100/- as per Annexure-IX of SBD (clause no. 1.26- i.e. Disqualification of Bidder of Instructions to Bidders) is to be uploaded/ submitted with techno-commercial offer by all the bidders except Government Organizations and/or Public Sector Undertakings.
4. The Tender Acceptance Letter to be given on letter head of company of the bidder as per Annexure-XI of SBD (clause no. 1.16- i.e. Deviations from Terms & Conditions/Tender acceptance letter of Instructions to Bidders) is to be uploaded/submitted with techno-commercial offer.

(6) **Techno-Commercial Bid** :Bidders must positively complete e-tendering procedure at [www.mptenders.gov.in](http://www.mptenders.gov.in). Bidders shall have to submit the following documents online in the website:-

1. Their complete techno-commercial offer containing detailed work description, specification and all commercial terms & conditions. This document should not contain any price part.
2. Techno-commercial information in the form of questionnaire and schedules (downloaded from website and filled as per instructions). The online submission of duly filled questionnaire and schedules is mandatory. Terms & conditions filled in questionnaire shall be treated as final. The requisite documents as per NIT i.e. credential & PQR related to financial status/ experience for supply of tendered items and as per questionnaire should only be uploaded.

(7) **Price Bid :-** Bidder shall have to download the Price bid format from website and after filling prices of quoted tendered item, the same is to be uploaded as per instructions therein. **Physical submission of price bid will not be considered.** The price bid of techno-commercially qualified bidder shall be opened online at the notified date at [www.mptenders.gov.in](http://www.mptenders.gov.in). Bidders can view information of date of price bid opening on website.

(8) **Important Instructions:**

1. **Vimla Private Railway Siding (Alpha code PVIT) is not allowed to quote for dispatch of coal.**
2. **No physical documents are required to be submitted by the bidder. However, EMD can be submitted in the form of BG in accordance with clause no. (4) of the NIT.**
3. **The clause No. 1.42-II of Instructions to Bidders of SBD "Quantity Distribution" is applicable for the tender.**
4. **Bidders/JVC are not permitted to seek Financial/Technical Qualification on the credentials of their Parent/Associate companies if they are not participating in tender with them as JVC.**
5. **The multiple bids submitted in same tender by sister concern/subsidiary/parent company are liable to be rejected.**
6. **The offers received without pre requisite credentials /PQR documents, shall be summarily rejected. Decision of MPPGCL in this respect shall be final.**
7. **Notwithstanding anything stated above, MPPGCL reserves the right to assess the creditability, capability and capacity to perform the contract. Should the circumstances warrant such an assessment in its overall interest, bidder shall furnish additional documents to substantiate its claim.
