**Amendment**

The revised rates for reimbursement of TA/DA admissible to personnel of MPPGCL were made applicable vide MPPGCL's order no ED(HR&A)/MPPGCL/DS-I/1466-67 dated 13/04/2017 in accordance to GoMP's memo no F-4-2/2016/Niyam/IV dated 5.11.2016.

The aforesaid order dtd 13.04.2017, so far it relates to the foot-note below the para (6) "Expenses incurred on local Transport " towards reimbursement of Taxi Charges on tour to Bhopal, Indore, Gwalior & Jabalpur is concerned, is hereby amended to the following extent:-

"The restriction, for reimbursement of Taxi charges to officers, on official tour to four Rajbhogi towns i.e *Bhopal, Indore, Gwalior & Jabalpur* under Category-A & B only and ceiling of 2/3<sup>rd</sup> of the rates mentioned in the table appearing under para (6) of MPPGCL's order no. ED(HR&A)/MPPGCL/DS-I/1466-67 dated 13/04/2017 is hereby removed, keeping other terms & conditions of the said order unchanged".

The above provision shall be made applicable with effect from the date of issue of order and TA/DA claims already settled shall not be re-opened.
